

TERMS AND CONDITIONS OF THE SHOPPING WEEKENDS WITH UNICREDIT BANK MARKETING EVENT

The purpose of this document is to provide a complete and clear description of the terms and conditions of the Weekend Shopping with UniCredit Bank marketing event (hereinafter referred to as the “Event”). This document is the only document that governs the terms and conditions of this Event. These may only be amended by written amendments to this document or a new full version of the terms and conditions of the Event. The Bank reserves the right to unilaterally amend these terms and conditions during the Period of the Event.

1. ORGANISER

The Event is organised by UniCredit Bank Czech Republic and Slovakia, a.s., with its registered office in Prague 4-Michle, Želetavská 1525/1, PC: 140 92, ID No.: 64 948 242, registered in the Companies Register of the Municipal Court in Prague, Section B, File No. 3608, operating in the territory of the Slovak Republic through its branch office: UniCredit Bank Czech Republic and Slovakia, a.s., pobočka zahraničnej banky, with its registered office at Šancová 1/A, 813 33 Bratislava, ID No.: 47 251 336, registered in the Companies Register of the Bratislava III Municipal Court, Section: Po, File No.: 2310/B (hereinafter referred to as the “Bank” or “UniCredit Bank”).

2. TERMS

Unless the context otherwise requires, the terms set out below are used solely for the purpose of these terms and conditions of the Event.

Current Account – a payment account for natural persons who are not entrepreneurs, held with UniCredit Bank in EUR, to which a standard or gold Mastercard debit card is issued.

Client – a natural person over 18 years of age who is a Current Account holder and who has been contacted by the Bank via push/InApp notification in the Smart Banking app and/or by email to join the Event.

Prize – a cash amount of up to EUR 200. The specific amount of the Prize depends on the amount paid during the weekend shopping, up to a maximum of EUR 200, which will be paid to the winner’s Current Account with the Bank.

Period of the Event – from 1 October 2024 until 31 January 2025. The Bank reserves the right to extend the Event or terminate it early.

Selected UniCredit Group Companies – UNICREDIT S.P.A., organizačná zložka Slovensko, UniCredit Leasing Slovakia, a.s., UniCredit Fleet Management, s.r.o., UniCredit Factoring Czech Republic and Slovakia, a.s. And UCTAM (UniCredit Turn-Around Management) members.

Tied Financial Agents (the VFA) – the Bank’s financial intermediaries in their capacity as Tied Financial Agents for the deposit-taking and lending, housing and consumer credit sectors.

Tied Investment Agents (the TIA) – the Bank’s financial intermediaries in their capacity as Tied Investment Agents for the capital market sector.

Employee – any natural person who at any time during the term of the Event is in an employment relationship with the Bank or a Selected UniCredit Group Company, TFA and TIA officers, including persons temporarily removed from the register of active employees (e.g., persons on maternity and parental leave).

3. INVOLVEMENT IN THE EVENT

The Client participates in the Event by making a payment of at least EUR 50 with the Mastercard payment card (standard, gold) issued to the Client’s account during the Period of the Event at merchants or online (cash withdrawals from ATMs are not considered to be payments). Only payments made by the Client on weekends during the Period of the Event will be considered as part of the Event, and the Client may make more than one payment that meets these conditions.

All Employees and Tied Financial Agents’ and Tied Investment Agents’ officers are excluded from the Event.

4. EVALUATION AND DRAW

All weekend payments made by the Client that meet the conditions set out in point 3 above are included in the draw. The decisive period for the draw is the particular weekend in which the payments were made. Ten winners will be drawn each weekend. You can only win once per one Mastercard debit card in a given draw weekend. If two or more transactions made with the same Mastercard debit card are drawn at random on a particular weekend, the first transaction drawn is always the winner. An additional draw will then take place to select 10 unique winning transactions. The Client (winner) will be informed about the prize by SMS message no later than the end of the following month in which the draw took place.

5. PRIZE AND CREDITING DEADLINES

Prizes will be determined by random drawing with independence of random selection of winners.

The amount of the Prize is equal to the drawn amount of the specific amount paid during purchases, up to a maximum of EUR 200.

The Prize will be paid to the winner by the Bank to the winners' Current Account no later than 30 days after the winner has been notified of the Prize.

6. PERSONAL DATA PROCESSING

The Event Participant acknowledges that the information provided will be processed by the Organiser (as controller) in accordance with the General Data Protection Regulation No. 679/2016 as amended for the purpose of evaluating the Event, informing the Event Participant about the payment of the Prize. The data processing period for the purposes of the Event is one year from the end of the Event.

7. FINAL PROVISIONS

The terms and conditions of the Event take effect on 1 October 2024 and are available on <https://www.unicreditbank.sk/sk/ostatne/mastercard.html>.

Any changes to the terms and conditions of the Event, including any changes to the Period of the Event, shall be published in the same manner as the initial announcement of the terms and conditions of the Event.

There is no legal right to the Prize and it is not legally enforceable.
