Types of prices	
Term	Definition
Limit	Specified maximum/minimum price, for which a client ordered to buy/sell a financial instrument.
Market	Unspecified price, for which a client ordered to buy/sell a financial instrument. The order will be executed for a current price available at the relevant market.
Stop*	Activation (stop) price, when a client order is changed to a market order and is subsequently executed for a current price at the relevant market.

Types of settlement	
Abbreviation	Definition
DVP	delivery versus payment (delivery v. cash settlement)
OTC	over the counter (off the exchange market)
DVx	over the counter transactions with cash settlement
PFx	sort of deal settlement (type of Borrowing)
RVx	sort of deal settlement (type of Repo or Reverse Repo)
BVx	sort of deal settlement (type Buy/Sell Back or Sell/Buy Back)
DFP	delivery free of payment (delivery with no cash settlement)
Evx	over the counter transactions with cash settlement

Note: "x" means a period of settlement, represents number 0 - 7, e.g. DV3 or RV0.

Types of orders	
Market	
Buy Order	A bank buys a financial instrument for the lowest available price at the moment of submitting an order to the market.
Sell Order	A bank sells a financial instrument for the highest available price at the moment of submitting an order to the market.

Limit	
Buy Order	A bank buys a financial instrument for the limit price specified by a client, alternatively lower price if the market conditions allow it during the order validity.
Sell Order	A bank sells a financial instrument for the limit price specified by a client, alternatively higher price if the market conditions allow it during the order validity.

Stop Loss*	
Buy Order/ Sell Order	At the moment when a price of a financial instrument reaches the stop price specified by a client, the order is activated (i.e. it is changed to a market order) and a bank buys/sells a financial instrument for the best price available at the market.

*Regarding technical options of service provider it is not possible to execute Stop orders.
